## Terms and Conditions

Please Read Carefully!!!!

1. Dates are reserved only with a nonrefundable retainer/deposit of 50% of the package total (unless otherwise specified), paid by cash or check on date of the signing of this contract. The retainer will apply toward the contracted services listed previously. All cancellations must be made in writing by the contracting party. In the event of cancellation, any amounts paid over and above the nonrefundable retainer will be returned, less liquidated charges for services rendered up to that date.
2. At any event requiring services of the photographers/assistants for over 4 hours, the contracting party will provide a meal. Please ensure that you have made this arrangement with your coordinator/caterer. If no arrangements are made, it will result in your vendors needing to leave the property to purchase food.
3. Missed payments will result in forfeiting the contracted date.
4. Once a service is chosen or an order is placed and all necessary payments made, the sale is final and nonrefundable. No verbal changes will be accepted. Any schedule or order changes must be documented, submitted in writing, and signed by both the contracting party and the studio for confirmation and mutual authorization.
5. The above signed will be notified upon completion of the digital preview and of the final order.
6. The above signed acknowledge that they have received, read, and understand A Perfect Day's current price list, which is incorporated herein by reference.
7. All finished digital images will be released on an archival disk for use (printing) by the contracting party if stated in package chosen.
8. Images will be available for viewing online within approximately 2-3 weeks.
9. Federal Copyright Laws preserve the right to exclusive use of negatives, digital files, and reproductions for A Perfect Day Photography. The studio shall only make reproductions for the client, client's family, friends, or acquaintances, or for the Photographer's portfolio, samples, self-promotions, entry into photographic contests or art exhibitions, editorial use, or for display within or outside the studio. If the studio desires to make other uses, the studio shall not do so without first obtaining the written permission of the client. *All photographs are copyrighted. It is illegal to reproduce professional photographs without consent from A Perfect Day Photography. If the package chosen contains a disc of all images, you have the right from A perfect Day Photography to reprint these at any location desired.*
10. A Perfect Day shall be the exclusive photographer retained by the client for the purpose of photographing the wedding or event here specified. Due to limited time restriction of the event, family and friends of the client shall be permitted to photograph the wedding/event as long as they do not interfere with the photographer's duties and do not photograph poses arranged by the photographer.
11. A Perfect Day cannot be held responsible for lack of coverage resulting from weather conditions or schedule complications caused by, but not limited to, anyone in or at the event, or by the church/synagogue restrictions. Due to the fact that weddings/mitzvahs/parties are uncontrolled events, we cannot guarantee any specific photograph, pose, or the final photographic results. We will, however, attempt to honor special requests. A Perfect Day may substitute another photographer to take photographs in the event of illness or inability to perform. In case of such substitution, A Perfect Day warrants that the substituting photographer shall be a competent professional.
12. If A Perfect Day cannot perform this agreement due to a fire or other casualty, act of God, photographers' illness, failure of transportation, or equipment, or other cause beyond the control of the parties, the studio shall return deposits made by the client but shall have no further liability with respect to the agreement. This limitation on liability shall also apply in the event that photographic materials are damaged in processing, lost in shipping, or otherwise lost or

damaged without fault on part of the studio. In the event the photographer fails to perform for any other reason, the studio shall not be liable for any amount in excess of the retail value of the client's order.

13. A Perfect Day takes utmost care with respect to the exposure, development, storage, and delivery of photographs. If A Perfect Day cannot comply with the terms of this contract, its liability is limited to a refund of the monies paid.
14. The contracting party agrees to pay all legal fees, attorney's fees, and cost that may be incurred in the process of collection of any or all of the unpaid balance owed to A Perfect Day.
15. If a court or proper jurisdiction rules that one or more provisions of this agreement are invalid, the remainder of this agreement shall remain in force.
16. RAW files: We shoot all photos in Raw format. These files take up large quantities of space and span about 15 dvds. Because of this, once edited, all files are converted to Jpeg and deleted once your online gallery has been generated, as we cannot accommodate Raw files for everyone. If the original files are something you must have, there will be a 400.00 fee to obtain these. A request for original files along with your edited files must be made at signing of contract, or else they will automatically be deleted upon completion of your editing.
